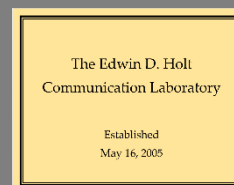

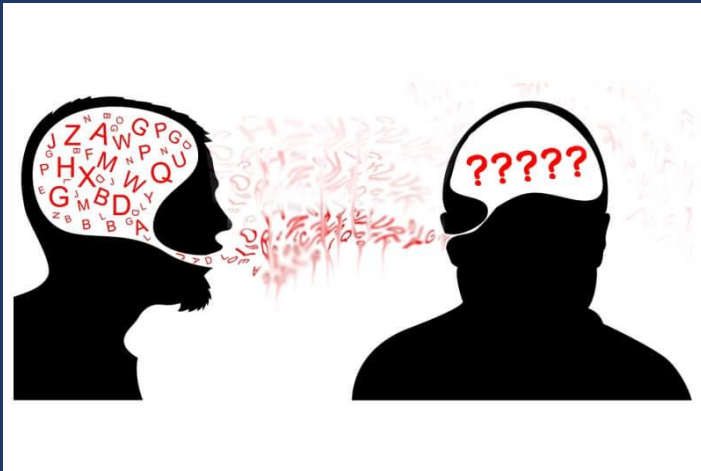

TERMINOLOGY

AAC = Augmentative and Alternative Communication

- devices or methods that supplement or replace natural speech
- can be no/low tech or high tech

SGD = Speech Generating Device

(AKA Communication Device)

- “durable medical equipment that provides an individual who has a severe speech impairment with the ability to meet his or her functional speaking needs.” (per the Centers for Medicare and Medicaid Services)

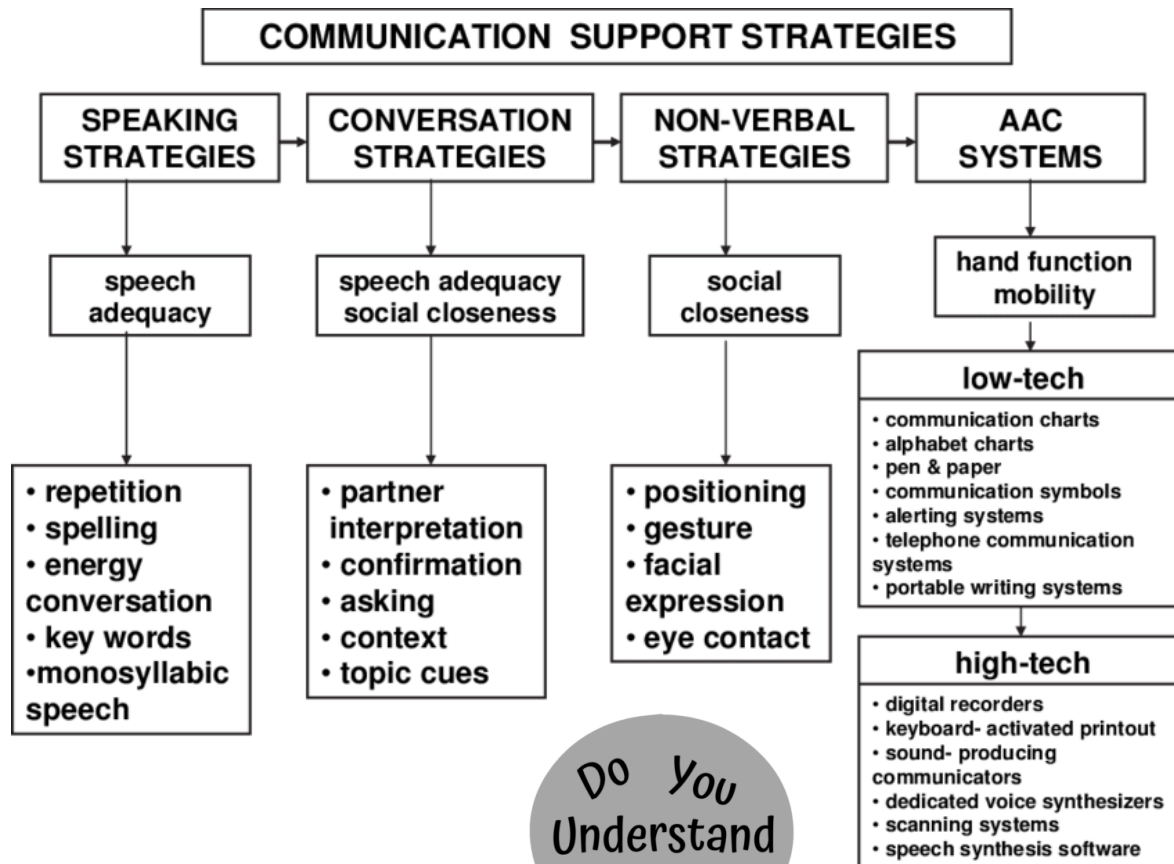

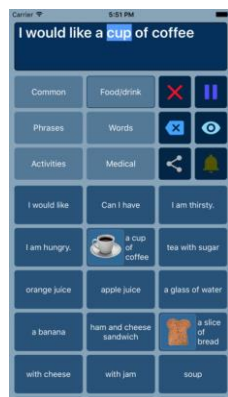

WHAT IS “BEST”



SGD FUNDING BASICS

- If you have Medicare Part B, SGDs are covered if:
 - Speech impairment is severe
 - SGD is medically appropriate
 - SGD is to be used solely by the individual with the speech impairment
 - SGD is Dedicated (as shipped, may allow for communication via email, text and/or phone but not full desktop)
- Most insurances will follow Medicare guidelines (80%)
- VA funding will cover cost of SGD/accessories for Veterans with ALS
- NOT covered for residents of nursing facilities or individuals under Hospice care

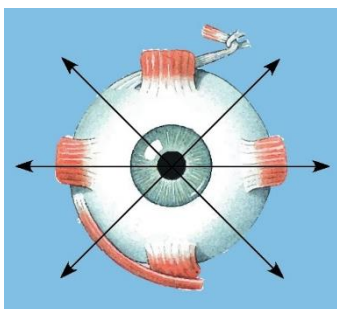

SGD TRIALS

REQUIREMENTS FOR FUNDING APPROVAL

- Rule out low-cost options
- Try multiple SGDs
- Justify access method
- Verify effective use
 - Calibration/cursor control
 - Communication



REQUIREMENTS FOR USER SATISFACTION

- Comfort with use
- Access to priority features
- Reliable support
- Realistic expectations
- Customization/adjustable settings
- Appropriate mounting

RATING/DOCUMENTING AAC TRIALS

Spelling accuracy	75%	90%	85%
Use of word prediction	maximal cues

Phrase storage/retrieval	moderate cues		
User area navigation	moderate cues

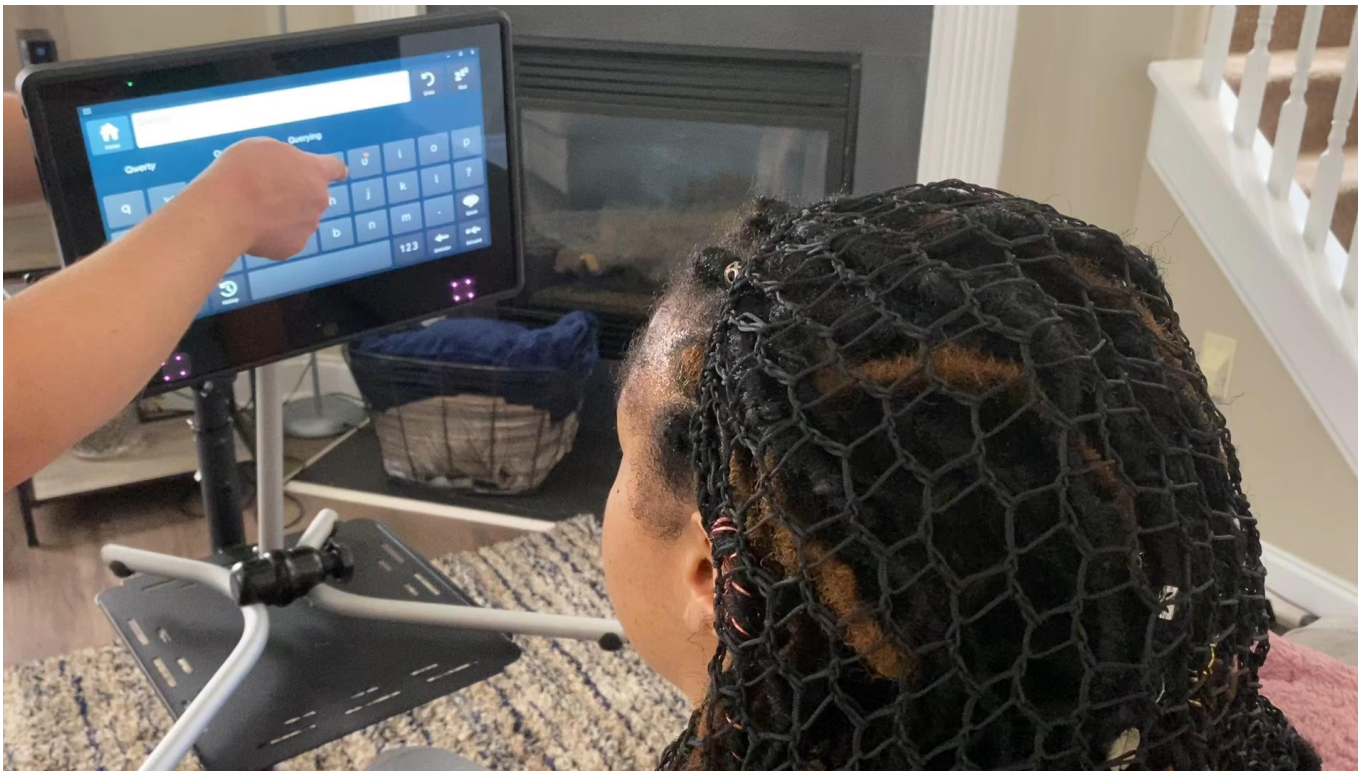

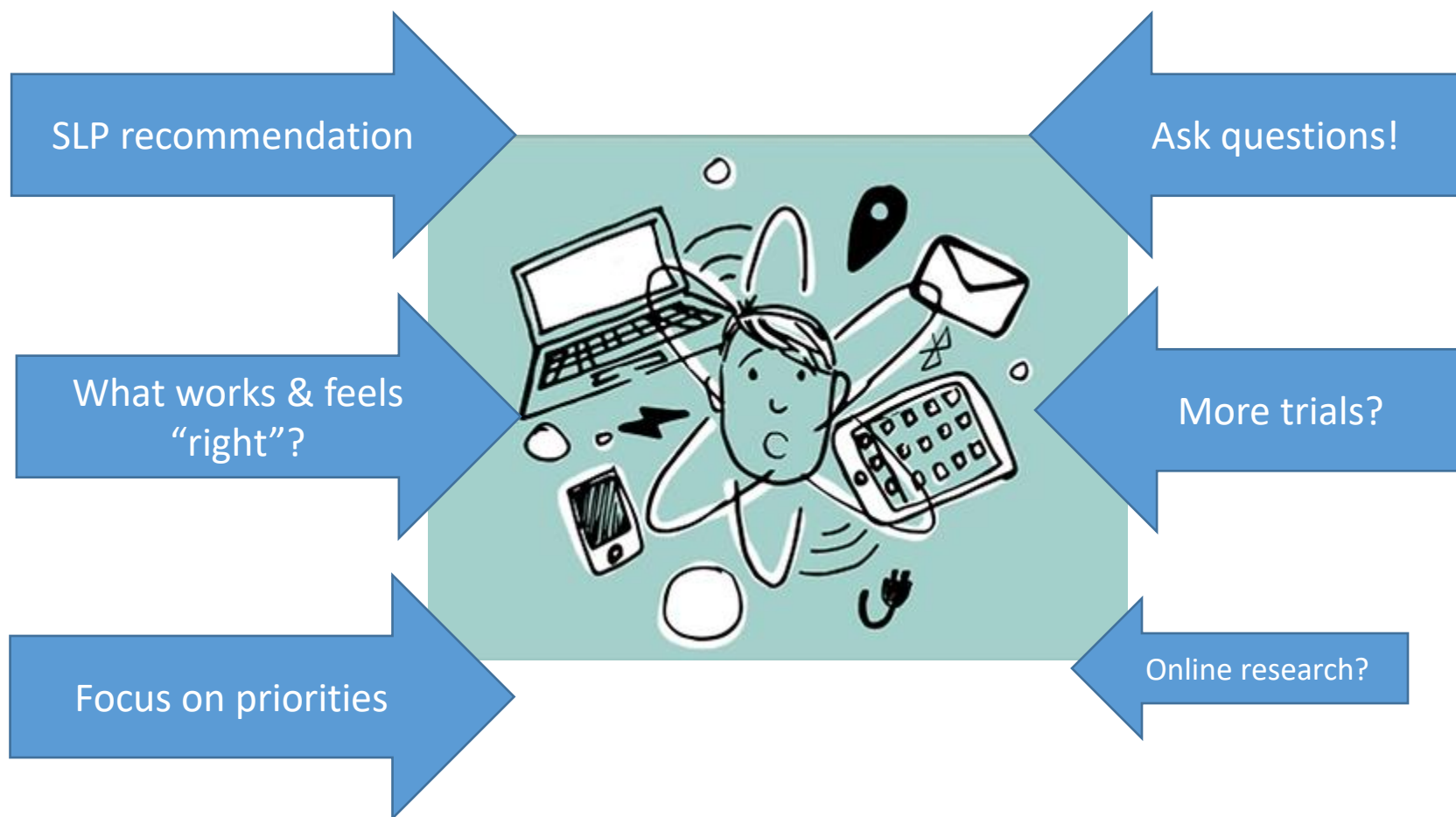

FUNDING CHECKLIST: who does what?

- ☐ Client information form
- ☐ Equipment quote
- ☐ Release/Assignment of Benefits Agreement Form
- ☐ Physician's Prescription
- ☐ SLP augmentative communication evaluation report
- ☐ F2F MD note mentioning need for SGD
- ☐ Copies of insurance, Medicare or Medicaid cards
- ☐ State Medicaid Forms (if applicable)
 - ☐ LMN/CMN
 - ☐ 30-day trial?

6-8 weeks (or more)



What can I do in the meantime?

- Use low-tech/quick access AAC
- Stay in touch with your SLP
- Reach out to SGD funding department
- Contact insurance if private (not M'Care/Caid)
